3. The Information we collect and how we use it

Except in the limited circumstances mentioned below, we do not collect your personal information when you enter or use our site.

Forums

We collect your e-mail address if you register as a participant in our forums. We only use this address to send you your password to enable you to log into our forums or to send you e-mail notices if you have elected to receive them. When you register, you can choose whether to permit your e-mail address to be viewable by other users of the forums.

If you complete the profile facility in our forums, it will be viewable by other users, but other than that, we make no use of it.

We do not monitor our forums or any of the communications between our users (e.g. private messaging). However, we may record and use particular communications that are posted in connection with any investigation of any possible misuse of the forums or any other communication systems that we operate.

IP addresses and Cookies

When you use our chat forums, we log the IP addresses of subscriber's computers which we use solely for administration and troubleshooting purposes.

We use cookies (files which are sent by us to your computer or other access device):

- in our chat forums, as they are part of the software that powers the chat forums and are needed to stay logged-in if you wish to post messages or reply to messages.
- On our main site to track the pages and articles visited.

If you want to delete any cookies that are already on your computer, please refer to the instructions for your file management software to locate the file or directory that stores cookies.

If you want to stop cookies being stored on your computer in future, please refer to your browser manufacturer's instructions by clicking "Help" in your browser menu. Further information on deleting or controlling cookies is available at www.AboutCookies.org.

Please note that by deleting our cookies or disabling future cookies you may not be able to post messages in our forums.

The information derived from use of cookies will be aggregated to provide statistical information about the usage of our site. However, we do not use any information derived from cookies, nor any IP addresses we collect, to identify any individual user of our site.

Apart from the uses described in paragraph 3 above the only circumstances in which we would disclose any of this information to any third party are: if ownership of all or part of our website were transferred, in which case any purchaser would only be entitled to use that information in a way consistent with this Privacy Policy; or if we are required to do so by any regulatory or criminal authority.
